## Deposit Agreement for Havanese Puppy

1. The applicant(s) ensures that the information given to the breeder is truthful and accurate.
2. The applicant(s) shall pay a **Non-Refundable** Deposit of **\$500.00** in consideration of a puppy by cheque or E-mail money transfer through your online banking system. Email payment to [cdrake@bell.net](mailto:cdrake@bell.net) . Security question – What is this deposit for? Answer- Havanese
3. The applicant understands that if a puppy of their preference for sex or colour is not available from a particular litter then the applicant shall wait for a puppy from the next litter.
4. The applicant(s) understands that the puppies are chosen on the basis of the order in which application fees are received and that “show quality” puppies are chosen first and receive priority over “pet quality” puppies.
5. The breeder cannot and does not in any manner guarantee the applicant a puppy from their litter of choice. While the breeder is careful not to “over-commit” the puppies from any given litter, the breeder cannot make guarantees where less than 4 puppies are born.

6. The applicant(s) understands that the deposit fee is **NON-REFUNDABLE**. Should the applicant decide not to be considered for a puppy, the applicant forfeits his/her application fee.

7. The breeder reserves the right to not place a puppy with the applicant should the breeder feel that the applicant cannot provide a suitable home. Such decision may result from, but not limited to, occasion where the applicant has given non-factual information to the breeder. In the case where the breeder chooses not to place a puppy with the applicant the breeder shall return the application fee.

8. The application fee for an Ashstone Havanese puppy is \$500.00. In the case where this fee has been paid by cheque and the cheque is returned N.S.F. the application shall replace the payment in cash and an additional \$50.00 for service charges incurred. Failure to make such payment shall void the application and the applicant(s) shall no longer be considered for a puppy.

9. Payment schedule as follows:

**Total Cost of Puppy - \$1,500.00 + \$195.00 HST = \$1,695.00.**

**Deposit - \$500.00 (non-refundable) MADE PAYABLE TO CHERYL DRAKE**

**Balance of payment, \$1,195.00, shall be paid in cash, money order or email money transfer prior to the puppy leaving Ashstone or at time of pick-up.**

10. The applicant further agrees to the following terms:

(a) Visitation of puppies shall not occur before the puppies are six weeks. Visitation is by appointment and is at the discretion of the breeder (dependent on the health and comfort of the mother and her puppies). Puppies shall be handled at the discretion of the breeder only and parents must ensure that children are supervised at all times, that the mother and puppies are treated kindly and carefully. Adverse behaviour will result in termination of visitations.

(b) Puppies are released from Ashstone Kennels at 10 weeks of age. Ashstone Kennels will hold puppies after 10 weeks at the cost of \$75.00 per week.
